Secretary:

- Thanked the association for their patience as he has been busier than in years past and hasn't had as much time to stay current with his duties.
- Discussed an email from a youth group in New England who was very complimentary of the SDUA website.
- Reminded the association to visit the website often and let the Secretary know if anything needs to be added so it's helpful for our members.
- The new member exam is due for a rewrite. It should be rewritten to reflect the NFHS Rulebook which is the rule book now sent to the members (instead of the MLB rulebook). Also, the paper copy of the exam will be discontinued. The electronic exam is automatically graded, and the turnaround time is instant instead of taking many days to register a new member.
- During lunch, each meeting attendee was asked to fill out a card. These cards will be reviewed and implemented in the District Clinics.
 - 1. One item (rule or mechanic) you would like to see covered at the District Clinic.
 - 2. One Mechanic you struggle with the most on the field.
- 6. Report from SD Amateur Baseball.
 - A. Joe Schlimgen: State Tournament went well.
 - B. Rock Rockafellow: Asked that more umpires apply for the State Amateur tournament.
 - C. Brock Sundall: SDABA will discuss the last 3 years of MLB rule changes and communicate the SDUA which rules the SDABA will and will not be adopting for their games. The League-specific rules will also be updated.

- 7. Report from SD Legion Baseball.
 - A. President Clark will reach out the Legion Athletic Commission to determine what recent MLB rule changes Legion Baseball will and will not be adopting.
 - B. Senior A and B State Tournament umpires are selected by the Legion Athletic Commission.
 - C. Junior A and B State Tournament umpires are hired by the tournament host.
 - D. Encouraged members to have their local towns to apply if interested in hosting a state legion tournament.
- 8. Report from High School Baseball. Brock Sundall:

 - D. State A Tournament will be a 2-day tournament.
 - E. State B Tournament will remain a 2-day tournament. It will not be held at Sioux Fall Stadium this year. The tournament site is undetermined.

10. New Business:

A. SDUA Hall of Fame:

- For the past several years, the SDUA HOF inductees have been honored at the Amateur Baseball Hall of Fame banquet. In the last few years, the SDUA's inclusion in these banquets has slipped. The SDUA HOF Committee and the SDUA officers will work with the Amateur Baseball banquet to ensure our inductees are properly honored with biographies, etc.
- Rock Rockafellow explained that the Honorary Umpire is nominated based on their contributions to baseball
 in South Dakota and isn't necessarily umpire specific.
- President Clark asked the District Umpires to provide qualified umpires and honorary candidates to the HOF
 committee. The invitation was also extended to all SDUA members. If you have a candidate that you feel is
 qualified for the SDUA HOF, please contact a Hall of Fame committee member or the SDUA.

B. Winter Meeting execution:

- Recent year's meeting costs have increased considerably. The 2023 meeting cost was \$1,237.12, which
 averaged \$47.58 per member in attendance (26 members attended the 2023 meeting).
- The SDUA officer's intention is to keep the meeting in the central part of South Dakota. Chamberlain has been a good location for us in the past number of years.

- The SDUA officers have looked into other meeting locations in the Chamberlain area.
 - Brock Sundall offered St. Joseph's School, as they have conference rooms with projectors and video equipment. Use of the space would be free of charge. The SDUA would likely make a donation to the school.
 - SDUA officers will look into meal options. A few members have volunteered to prepare a meal. We will look into catering options as well.
 - ♦ Final arrangements for a meeting location will be made as we get closer to the 2025 meeting.

C. District Meeting/Clinic:

- Overall, the impression of the 2023 clinic format was positive. We look to improve in 2024.
- The 2024 clinics will follow a similar plan with the intention of adding some improvements:
 - Make an effort to host the clinics at facilities that will allow for better mechanic and "on-field" training (gyms and hitting facilities, instead of bars, restaurants, and classrooms).
 - ♦ Try to add video training to the clinics.
 - We will use a committee that will travel to each clinic to host. This worked well last year in conveying a more uniform message across the state. These clinicians are to be determined. As in 2023, they will be paid mileage to attend these clinics.
- D. Communities not using SDUA Umpires: Some communities are intentionally not using SDUA umpires for their VFW and Class A games. Main reason was cost savings. Discussion was had regarding how we work with these communities to encourage them to use our members. Prove to them that our members are worth hiring.

E. Open Floor:

- Jesse Devine: There was a mix up between the SDUA and the SDHSAA when ordering NFHS books for 2024. Since we received only 120, do we order more so we can provide enough books for each member as was approved at the 2023 meeting.
 - ♦ We purchase books from the SDHSAA at \$7.00 per book. Retail price is \$12.00.
 - ♦ It was voiced that not all members need/want a rule book.
 - The Secretary will add a question to the renewal form asking if that member requires a rule book and will send a book accordingly.

Motion by Jake Samp, Seconded by Mike Carda to order 100 more NFHS books, with the contingency to order more as needed. Approved.

- Rock Rockafellow: Addressed the meeting saying many of us need to take more pride in our membership in the SDUA. He feels we are pricing ourselves out the game, thus leading to financial stress to the teams. He charged us to ask ourselves if our intentions as umpires is to make money or to help baseball? Take pride while on the field.
