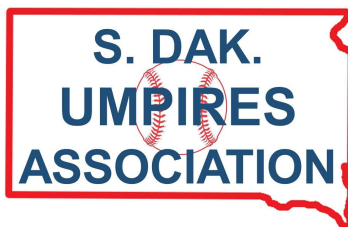

February 1, 2026, 11:30 AM

1. The meeting was called to order by President Matt Clark at 11:31AM. There were 30 members present. President Clark asked for a moment of silence in remembrance of Reed Harter. Introductions of those present followed.

6. Report from SD Amateur Baseball.

A. The SDABA will have their annual meeting on February 15.

B. League specific rules will be updated and posted on the SDUA website when available.

C. Mileage rate paid was increased to \$.70 per mile for umpires working the state tournament.

D. Game fees for the state tournament was increased to \$90/game

7. Report from SD Legion Baseball.

A. With the addition of the 14U division, we are asked to supply the big stick award for this level as well.

B. Game fees for the state Sr. Legion games was increased to \$80/game

C. For state Sr. tournaments, umpires that sit out the first championship game so they would be fresh for the if needed game, will be paid even if the if needed game is not played.

D. For regional best of 3 series, pay for the if needed game is not required.

E. PCBA (Mitchell) was granted reinstatement to Legion baseball.

F. Time clock of 120 seconds between innings and 150 seconds for pitching changes is asked to be enforced.

8. Report from High School Baseball. (See all HS points of emphasis at the end of this document)
- Safety 1st base will be required in 2027. Rules regarding the safety base are addressed in the NFHS rule book on page 3.
 - Hockey style catchers mask is required. There are 2 medical exemptions in the state. They will have documentation from the SDHSBA board to prove the exemption. No paperwork = no exemption.
 - Application for post season is live
 - 66 Varsity level teams registered for 2026
 - 105 Pitch count violation is not a gotcha moment. If pitcher violates the pitch count, player and coach are restricted to the dugout for the remainder of the game.
 - If there is a solo coach situation, and that coach is ejected from the game, the coach may remain in the dugout for supervision purposes.
 - For regional best of 3 series, umpires will be paid for all three games even if only 2 are needed.
9. Report from SD VFW Baseball.
- Jason Whiting was appointed by the VFW as the UIC for VFW baseball.
 - Jason was not able to attend to provide and further updates.
10. Set Mileage rates:
- Motion to set mileage rates for any mileage paid by SDUA to be the current state rate. Motion by Jesse Devine, second by Jason Vaith. Motion carried.

C. Liability Insurance:

- Do we purchase for 2026?

2. 2026 Premium is \$776.

Motion was made to renew liability insurance in perpetuity so long as the yearly increase did not exceed 15%. If the increase was in excess of 15% from the previous years premium, it must be brought back to the membership for approval. Motion by Yogi Millslagle, seconded by Connor Singhisen, motion carried.

D. By-Law Change:

Motion was made to approve changes with the exception of Article VIII (Duties of Officers) section 5. Motion was made by Connor Singhisen, seconded by Chris Mercado, motion carried. New By-Laws will be posted on the SDUA website.

E. New Member exam: 185 exams, avg score 22/30

1. Connor Singhisen reported that the new exam is almost complete. Once it is completed, it will replace the current exam for new members.

12. New Business:

A. Current member recertification.

1. Discussion was had regarding current members taking a test to maintain membership. District umpires were assigned with developing a plan to do so.
2. No motions were made.

B. SDUA Uniform Requirements

1. Replace SDUA patch on shirt with new cap design
 - Discussion was had about changing the current cap design to incorporate a variation of the SDUA logo.
 - Motion was made to change the cap design to be used as an alternative to the SDUA patch on the shirt. Motion was made by Connor Singhisen, seconded by Rich Rockafellow, motion was defeated
2. Set SDUA primary shirt color, cap color, jacket color, pant color.
 - Motion was made to set the primary shirt color to sky blue with the black panel, the cap color to black, jacket color to black, and pants to charcoal gray. Motion made by Chris Jackson, seconded by Johnny Kirchner, motion carried.
 - Website will be updated to reflect these changes.

C. Post-Season application process:

1. Results from the survey were discussed. Most common responses were:
 - Can't commit to the time needed
 - Don't feel qualified
 - Tournament location
 - Don't work that level of baseball
2. Point of clarification:
 - Amateur tournament application is not for the entire tournament. Individual dates can be selected

D. Ump-O-Gram

1. Greg Warren will remain as Ump-O-Gram Chairman. He will coordinate with District umpires to provide Ump-O-Grams throughout the season.

E. Open Floor

1. Lineup card holders

- Lineup card holders were provide as recognition to all 10 and 11 year umpires last year and will continue to be provide to 10 year members.
- Motion was made to purchase the 10 year recognition lineup card holders for current members with 12 or more years of membership. Motion was made by Connor Singhisen, seconded by John Witcraft, motion carried.

2. Meal for State Legion Umpires:

- The SDUA has previously paid for a meal for umpires at the State Sr. Legion tournaments
- Discussion was had to limit the dollar amount per person for that meal.
- No motion was made.

3. Winter meeting:

- The officers would like to thank Brock Sundal and St Joseph's Indian School for providing the location and providing for the wonderful meal from Ma's Kitchen(Roast Beef, Mashed Potatoes, Cheesy Green Beans, Roll, and Cookies).
- A donation of \$200 was made to St. Joseph's Indian School for use of the facility.

13. Election of Officers:

- With no further nominations, motion to cease nominations and cast unanimous ballot was made by Joe English, seconded by Lloyd Jones, motion carried.

****Double 1B will be mandatory in 2027. SDHSBA is allowing for implementation in 2026 if so desired. The State Tournament games will have a double 1B.**

15-Run Rule (now in SDHSBA Manual)

Player/Coach Communication devices approved by NFHS (one-way from dugout to catcher)

Player Wristbands-only worn on player's wrist or forearm, not on their belt

Reminders:

Bats

BBCOR and/or wood and wood composite bats are now allowed

Baseballs

Need to have the NOSCAE stamp

Catcher's Helmet

NFHS requires catchers to wear a hockey-style mask—We have 2 doctors ordered exceptions to this. They have documentation for this and should show it. (PGDCWL and SF player) Otherwise, NO exceptions

Catchers chest protector also needs to be NOSCAE stamped

Pitch Counts-Potential Violations

A potential violation of the 105 maximum pitch count must be brought to the attention of umpires and opposing coaches before the actual violation takes place. At this time, coaches and scorekeepers will come to an agreement on pitch counts before the game resumes.

Coaches, it is your responsibility for making certain that your pitchers are complying with the pitching limitation rule. After each half inning those responsible for tracking pitches will confirm the number of pitches for that half inning. Any discrepancies need to be worked out at that time. If a dispute cannot be resolved, the number calculated by the home team will stand as the official number. Once the next inning has begun, the numbers from the previous half inning are final. Umpires will not be involved in tracking or confirming the number of pitches. The penalty for violating the 105-pitch limit is that the coach and player will both be removed from the game. This is not considered an ejection though. If found in the middle of the at bat, the count will continue with the new pitcher.

Reminder of the Line Up/DH options

Traditional DH-can DH for any position player and the position player and the DH are locked into that spot in the batting order and can never be in the game defensively at the same time.

Player/DH

Straight Nine-No DH

Coaching Helmets

Coaches are not required to wear a helmet; however, if a player is coaching a base, they must wear a double-flapped helmet

Jewelry

Jewelry is now allowed; however, a provision does remain that any jewelry an umpire believes poses harm or injury to the wearer or their opponent shall be immediately removed. 1-5-12, 3-3-1d

Umpire Requirement for regular season and post season

SDHSBA requires two registered umpires with the SDUA during regular season. Umpires for the post season shall be certified. So if looking for a partner, or assigning, take this into consideration.

Post Season Application Link will be on the SDUA website. Deadline to apply is April 1st, so that our Selection Committee can finalize selections and notify umpires with as much advanced notice as possible. Once you submit the application, you will receive an email confirmation.

We are planning to pay \$80/game (was \$70 in 2023) and \$1.00/mile one way and/or riding mileage of \$0.50/mile one way for umpires that ride together). Lodging will also be covered if necessary for Super Regionals and State Tournament. You will leave your Super Regional games with game fees paid by the host team. I will write mileage after the state tournament and send those checks. Class A Supers umpires will be paid \$240 in game fees regardless of whether it goes two or three games. You are expected to block off the second day, so we are compensating you for that.

The link is on the SDUA website. Please fill it out ASAP so that notifications can be made to the appropriate people. In 2025, we had 20 total player/coach ejections, 14 players and 6 coaches. This is up from 2024 when we had 10 player and 4 coach ejections (12 player and 3 coach ejections in 2023).
